**Recommendation:** *Members objected to this application and repeated their comments:*

- *Parking at that end of the town centre is already used during the day by local businesses and shoppers. If this parking is lost it will affect the regeneration of the town centre. There is no parking shown on the application and the areas suggested for parking facilities on Stangrove Road, which has extensive parking restrictions; Lingfield Road, or Tekram Close are impractical as these streets are much further away from the proposed development site and the relief road is already a very busy road.*
- *The demolition of a Victorian building for a new block of flats will damage the historic market town appearance, especially the view when entering the town from the North end.*
- *The height of this building is not in keeping with the street scene and also inappropriate for a town the size of Edenbridge. It will cause overlooking and loss of light for some neighbours and is over development in the in the conservation area.*

**12.1 Highways Improvement Plan - updates on White Gates**

Another raised that there are two SIDs, one Council owned and the other used for Speedwatch which is SDC owned. There was no objection to refer to Council. Following discussion, Members unanimously **agreed** Cllr Stockdale to work with the Community Warden, and to produce summary reports on the data, to be reported to members approximately six monthly.
