

11.1 **Sevenoaks District Draft Local Plan**

**Sevenoaks District Council is drafting a new Local Plan to cover the period up to 2042 – an important document that sets out what can be built and where over the next 15 years.**

Edenbridge Town Council is a statutory consultee and as such, responded to Sevenoaks District Council's previous Local Plan Regulation 18 (Phase 1 and 2) consultation in 2023 and 2024.

Phase 3 of the Regulation 18 consultation is expected to run from 23 October to 11 December 2025. The Town Council will respond, and will also host consultation events for Edenbridge residents to find out more, to talk to councillors and to help make their own

informed representations. Dates will be confirmed after 9 October.

While the Town Council cannot adopt a formal position until it has fully reviewed the proposals, we will work closely with our planning consultant to examine the documents and prepare our responses.
